



**INVITATION TO BID FOR SUPPLY AND DELIVERY OF  
THIRTY (30) UNITS BRAND NEW SATELLITE PHONE EACH WITH 250  
UNITS TOP-UP LOAD (PER UNIT)  
FOR THE PHILIPPINE AIR FORCE (PAF)**

1. The **Philippine International Trading Corporation** and **Philippine Air Force**, through the **AR Nr 0616 dated 17 May 2019** intends to apply the sum of **Pesos: One Million Five Hundred Fifty-Seven Thousand (₱1,557,000.00)** being the ABC to payments under the contract for **Supply and Delivery of Thirty (30) Units Brand New Satellite Phone each with 250 units Top-Up Load (per unit) for the Philippine Air Force (PAF)/ Bid Ref. No. MPG-B1-2021-025 3<sup>rd</sup> Rebid**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Philippine International Trading Corporation (PITC)** and **Philippine Air Force (PAF)** now invite bids from authorized Philippine Suppliers/Distributors with National Telecommunication Commission (NTC) license for the Satellite Phone each with 250 units Top-up Load (per unit) for the above Procurement Project (hereafter referred to as GOODS). Delivery of the Goods is required as follows:

3. Bidders should have completed, within the **last five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders). Similar shall mean “**Communication Equipment**”
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183
6. Prospective Bidders may obtain further information from the **Assigned BAC Secretariat** per schedule at **3/F, NDC Building, 116 Tordesillas Street, Salcedo Village, 1227 Makati City** and inspect the Bidding Documents at the address given below during **9:00AM – 2:00PM on weekdays only**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person, by facsimile, or through electronic means.

8. The **Philippine International Trading Corporation** will hold a Pre-Bid Conference on **20 January 2021, 08:00PM via Video Conference (Zoom)**, which shall be open to prospective bidders.
9. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **05 February 2021, 08:00PM**. Late bids shall not be accepted.
10. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 14**.
11. Bid opening shall be on **05 February 2021, 08:00PM via Video Conference (Zoom)**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
