Query 1	Does the tender also require the delivery of 114,000 qty. ammunition?
PITC/ PNP REPLY 1	Yes, the proponent/supplier is required to deliver the 114,000 qty ammunition together with the rifle. All the requirements mentioned in the PNP Additional Requirement for Sniper Rifle, 7.62mm must be complied with and will be inspected during the acceptance of goods as to quantity delivered.
Query 2	Do you approve the double-barreled gun ZU-23mm as a firearm under the required references (50% of ABC)?
PITC/ PNP REPLY 2	If you are referring to the Similar Contract/s for the Single Largest Completed Contract requirement, the definition of “similar in nature” remains the same. Please refer to Section III. Bid Data Sheet (BDS) Clause 5.3.
Query 3	Is Annex V-A1 also part of the inquiry?
PITC/ PNP REPLY 3	We do not understand your query.

Query 1	We would like to request for the reduction in quantity to 68 Units of Rifles, considering the required accessories (Rifle scope, Clip on thermal scope, Sniper Camouflage).
PITC/ PNP REPLY 1	Reduction of quantity from 114 to 68 units cannot be considered.
