The **Philippine International Trading Corporation (PITC)** and the **Intelligence Service, Armed Forces of the Philippines (ISAFP)**, through **PITC A.R NO. 0002898 dated 22 March 2018** intend to apply the sum of **Pesos: Two Million Six Hundred Sixty-Nine Thousand Nine Hundred Seventy-Four and 31/100 (P 2,669,974.31)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Supply of Labor and Materials for the Construction of Multi-Purpose Building of MIG12 for the Intelligence Service, Armed Forces of the Philippines (ISAFP) - One (1) Lot per PITC Bid Reference No. MPG-B2-2020-536 4th Rebid**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
